PLEASE NOTE: ALL passes for the 2021 season will be MAIL-IN/DROPBOX ONLY. Please allow at least 2 weeks to process. If you are purchasing a Westerly Town Beach Parking Pass, you do NOT need a separate Larkin Road Parking Pass.

ELIGIBILITY REQUIREMENTS & REQUIRED DOCUMENTATION:

You MUST be a Town of Westerly Resident. Proof of Residency may include:

- A. Valid Vehicle Registration with Westerly Address
- B. Valid Driver's License with Westerly Address
- C. Westerly Real Estate Taxpayer Verification
- D. Current Voter Registration
- E. Military Identification along with copy of lease or rent receipt.

Parking Pass **MUST** be on lower LEFT corner of Driver's Side windshield. Each pass will display license plate # from current registration. It **MUST** match vehicle plate. Parking Enforcement Officers will check for this.

Pass is **NON-TRANSFERABLE**.

Applications will NOT be accepted OR processed in person.
